Collection of Personal Information

Pacific Coast Flyers, Inc. may collect personal information, such as your e-mail address, name, home or work address, or telephone number. Information collected by Pacific Coast Flyers, Inc. is used solely for the purpose of club management. Pacific Coast Flyers, Inc. does not collect any information about your computer hardware and software.

We are not responsible for the privacy statements or other content on web sites outside of the Pacific Coast Flyers, Inc. web site.

Use of your Personal Information

Pacific Coast Flyers, Inc. and its operational service partners may use personal information to inform you of club activities, products, or services. Pacific Coast Flyers, Inc. may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Pacific Coast Flyers, Inc. does not sell, rent, or lease its customer lists to third parties. Pacific Coast Flyers, Inc. may, from time to time, contact you on behalf of external business partners about a particular offering that club management feels may be of interest to the membership. In those cases, your personal information (email, name, address, telephone number) is not transferred to the third party.

We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, processing transactions, or performing statistical analysis of our services. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

Pacific Coast Flyers, Inc. does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Pacific Coast Flyers, Inc. may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to:

- a) Conform to the edicts of the law or comply with legal process served on Pacific Coast Flyers, Inc. or the site;
- b) protect and defend the rights or property of Pacific Coast Flyers, Inc., including its web site; or
- c) act under exigent circumstances to protect the personal safety of users of Pacific Coast Flyers, Inc. or the public.

When we transmit highly confidential information (such as a credit card number) over the Internet, we protect it through 128 bit encryption.
